



# 8th SÜFFA Competition for Swabian Raviolis (Maultaschen)

## Information and participation conditions

### Organiser

Gesellschaft zur Förderung des Fleischerhandwerks Baden-Württemberg mbH - acting on behalf of the Baden-Württemberg State Association of Butchers' Guilds - and Landesmesse Stuttgart GmbH.

### Testing location

Messe Stuttgart, Messeplazza 1, 70629 Stuttgart

### Right to participate

The Competitions are open to every self-employed master butcher from Baden-Württemberg and Bavaria (only the Schwaben Administrative District), as well as their employees with specification of the employer. The participants must be a member of the competent professional butcher's organisation.

### General competition conditions/data protection

The submitted sample(s) must comply with the regulations pertaining to foodstuffs. Submitted samples will not be returned by the organiser. The costs of samples, which were registered but not submitted, will not be reimbursed.

Insufficiently stamped samples, samples submitted after the deadline and/or non-edible products will be excluded from judging; the paid participation fee will not be reimbursed. Would you please read our information relating to the recording of your personal data on page 4 of these registration documents.

### Participation fee

The participation fee per sample is €60.00 + 19% VAT = €71.40.

If more than two samples are submitted, one sample will be free of charge.

### Approved products

- Raviolis (Maultaschen) - the "traditional" raviolis (Maultaschen) from your company
- Soup raviolis (Maultaschen)

The filling may contain the following ingredients: sausage meat, mince, smoked pork belly, leek, parsley and/or other herbs, vegetables, onions, spinach, eggs, breadcrumbs. No separated meat may be used!

**Exceptions include fillings with fish and other seafood!**

### Sample size

2 x approx. 500 g raviolis (Maultaschen) per registered sample, each vacuum-packed.

### Number of samples

Every company may register a maximum of 3 samples from its own production.

### Judging criteria and their maximum number of points

Judging will be based on proven testing conditions (100-point scale); judging by the Baden-Württemberg State Association of Butchers' Guilds will take place in a cold and a hot state. Every sample will be heated separately in a vacuum bag in a water bath with the addition of standard and neutral meat stock.

1. Overall impression
2. Internal appearance/cross section (cold and hot)
3. Consistency
4. Smell and taste

Assessment table for the individual ravioli (Maultasche):

Gold	95 – 100 points
Silver	90 – 94.9 points
Bronze	85 – 89.9 points

# Data protection notice for SÜFFA Competitions

## Information on the collection of personal data of data subjects or third parties

### Information on the collection of data according to Articles 13 and 14 of the GDPR
